
LAMP Words for Life[™] App for iPad

The app is appropriate for beginning communicators who are just learning that they can affect those around them to skilled communicators with advanced language skills. It features structured language and includes three vocabulary files and features within the app to support language development from the current skill level throughout their life.

The foundations of the LAMP approach will be briefly reviewed as well as the principals behind the development of the Words for Life™ application. Participants will practice saying single words, phrases and short sentences in the 1-hit, transition and full levels. In addition, participants will learn how to program and customize the application as well as use the features of word finder and vocabulary builder. In the afternoon, a variety of AAC teaching strategies will be reviewed to help teams implement LAMP WFL in school or at home.
